1. The insurance under this Policy is subject to the following clauses hereto attached :-
 - 1.1 Fire & Explosion Extension Clause
 - 1.2 Local Jurisdiction Clause
 - 1.3 Terrorism Exclusion Endorsement
 - 1.4 Asbestos Exclusion Clause

2. The insurance under this policy is extended to cover legal liability of the insured in respect of accidental damage to the Insured's premise

 - 3.4 Any liability in respect of loss of or damage to any property caused by occurrences namely robbery, burglary, theft, mysterious disappearance and/or inventory loss.
